Fees and Refunds Policy

An applicant's place in a course is not confirmed until SHQ has received full payment of course fees. Course fees must be paid in full at least four (4) weeks prior to the course starting. Payment may need to be made earlier to secure a place in a course in high demand.

A course maybe cancelled (or the dates changed) if minimum numbers have not been confirmed four weeks prior to the course start. Course cancellations or changes in dates will be notified as soon as possible and a full refund made.

Participants are advised not to book travel arrangements until they are notified the course has been confirmed.

Refunds

A cancellation for a course must be given in writing. If cancellation notice is received by us:

- More than four weeks prior to the course/workshop starting then a full refund less an administration charge of \$55 including GST will be made.
- Less than four weeks prior to the course/workshop starting no refund will be made unless there is a waiting list for the course/workshop and the place is filled, in which case a full refund minus the above administration charge will be made.

Deferment to a later date is treated the same as a cancellation.

Substitution: A substitute may be nominated to attend in place of a participant after payment of the above administration charge (provided that there is adequate time for the substitute to complete any pre-course requirements).
